RELEASE AND WAIVER AGREEMENT

In consideration for permission to participate or be a spectator in the Snowshoe Bowhunter's Open, I agree:

- (1) that I understand that bowhunting and archery are potentially hazardous activities which may result in serious injury or death. I understand that there are inherent and other risks involved in these activities, including, but not limited to, being struck by arrows, slipping, tripping, or falling, being injured by adverse weather conditions (heat, cold, lightening, etc.), being injured by the negligence of other participants, and being injured by the negligence of the International Bowhunting Organization, its employees, officers, representatives, and agents ("I.B.O."), or of Snowshoe Mountain, Inc., its employees, owners, representatives, or agents.
- (2) to accept all risks of these activities, whether specifically listed in paragraph (1) above or not.
- (3) to follow all rules, instructions, and directions provided by the I.B.O. and Snowshoe Mountain.
- (4) to waive my right to bring any claims against I.B.O. and Snowshoe Mountain that arise out of or relate to my participation in the Snowshoe Bowhunter's Open event, and to release I.B.O. and Snowshoe Mountain from liability for any such claims. This waiver and release includes claims based upon negligence by Snowshoe Mountain. I further agree that I will indemnify, hold harmless, and reimburse I.B.O. and Snowshoe Mountain for all losses (including attorneys' fees and costs) from any claims brought by any persons or entities arising out of or relating to my participation in the World Championship event even where such claims are based, in whole or in part, on alleged negligence by I.B.O. or Snowshoe Mountain.
- (5) that all disputes arising under this Release or from my participation in the Bowhunter's Open event shall be litigated exclusively in the Court of Common Pleas of West Virginia.
- (6) I grant Snowshoe Mountain/I.B.O. permission to use photographic and/or video images of me for the purpose of marketing, publicizing and promoting the resort. I waive any right to be compensated for the use of my image and release Snowshoe Mountain/I.B.O. from liability for any claims, where such claims arise out of or relate to Snowshoe Mountain/I.B.O. use of my image.
